NOTE: REQUIRED ON ENTRY FORMS -- AKC DNA NUMBER

All dogs, except those with PAL/ILP registration, entered in the National Specialty will need to have an AKC DNA number. This applies to conformation and the Obedience and Rally companion events as well as the 4-6 Month Puppy Competition. DNA is NOT required for dogs accompanying children in the Pee Wee Special Attraction.

Since the Agility companion event is open to all-breeds, a DNA number is not required on Agility entries. DNA numbers are not required for Veteran Sweepstakes (unless the dog is also entered in one of the regular or single-dog non-regular National Specialty conformation classes, e.g., Veteran, Best of Breed, Hunting Dog, etc.) DNA numbers ARE required for Puppy Sweepstakes since they must be entered in the regular classes as well).

GRAND CHAMPION POINTS

At the judge's discretion, Grand Championship points may be awarded to: Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog, Select Bitch.

JUDGE'S AWARDS OF MERIT

Immediately following the Best of Breed competition, the judge may select, at his discretion, up to 10% of the superior quality specimens in the breed ring for an AOM. He is not required to award any, and may not award more than the number allowed based on the number showing. These would not include those exhibits previously awarded Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog, Select Bitch.

RESERVE WINNERS DOG AND RESERVE WINNERS BITCH MAJORS

Dogs designated Reserve Winners Dog and Reserve Winners Bitch will be awarded a three-point major, provided that the number of dogs competing in the regular classes of the Reserve Winner's sex total at least twice the number required for a five-point major in the region in which the event is held. Only those dogs actually competing are counted.

JUNIOR SHOWMANSHIP CLASSIFICATION

NOVICE CLASS* -- shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who at the time entries close have not won three (3) first place awards, with competition present, in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open at a licensed or member show. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

OPEN CLASS* -- shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show and who have won three (3) first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

MASTER CLASS -- will be for boys & girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year.

* The Novice and Open regular classes may be divided by age. Junior Class shall be for boys and girls who are at least 9 years old and under 12 years old on the day of the show. Intermediate Class shall be for boys and girls who are at least 12 years old and under 15 years old on the day of the show. Senior Class shall be for boys and girls who are at least 15 years old and under 18 years old on the day of the show.

2024 GSCA 4-6 Mo. BEGINNER PUPPY CLASS

JUDGE: DEBORAH DAVIS

The Four-to-Six Month Puppy competition shall be judged in one combined class for dogs & bitches that are four months of age and over, but under six months on the day of the event.

Entry and eligibility requirements include:

- AKC registration number or an AKC litter number will be required for all entries and an AKC DNA number.
- A foreign-born dog may enter this class if he/she is registered in the country of origin.
- · All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol
- Professional handlers from any country, members of their household and current assistants to professional handlers from any country may not personally exhibit dogs in the Four-to-Six Month competition. Dogs that are owned or co-owned by the aforementioned may compete but must be handled by a non-professional handler.
- Minors (under 18) with amateur status who reside with professional handlers from any country, and current assistants to professional handlers from any country that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may exhibit dogs in the Four-to -Six Month (Beginner Puppy) Competition. Entry fee: \$15.

GSCA PEEWEE CLASS - SPECIAL ATTRACTION

JUDGE: MARY BENJAMIN

The Pee Wee Special Attraction is a pre-Junior Showmanship class. The Pee Wee class is geared toward children 5–9 years of age. Children younger than five cannot participate in the Pee Wee Class Special Attraction. The safety of the children is a primary concern.

Each Pee Wee unit consists of the child, his/her parent/guardian/responsible adult, and the dog. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult. There is no entry fee required at this show. A dog must be at least four months of age to enter the Pee Wee class. Registration will be taken the day of the event.

- Bitches in season will not be allowed to participate. If pre-entered, a dog may be substituted that meets the eligibility requirements as specified by the club.
- · All dogs entered must have the proper lead and collar. No prong or buckle collars.
- A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.
- The dogs must be Gordon Setters, but do not need an AKC DNA number (unless entered in another class that requires it) and do not need to be AKC registered.
- In addition to an entry, a release must be signed by the child's parent or legal guardian. Please contact Event Operations at eventplans@akc.org to request the current version of the Pee Wee Release of Liability. There will also be Release forms available at the Show Secretsry's table for those who need them.

The safety of both the dogs and Juniors inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child. An additional lead, provided by the Club, will be at the Judge's table. At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.

NOHS (NATIONAL-OWNER-HANDLER SERIES)

The AKC National Owner-Handled Series is a celebration of the dedication and enthusiasm of owner-handlers and is open to purebred dogs that are at least six months of age.

Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form. Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers*, household members and current assistants** to professional handlers may not exhibit the dog in any NOHS competition during the entire show. For a detailed description of the National Owner-Handled Series, please visit the AKC website NOHS pages at:

* Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. **A current assistant is defined as anyone employed by a professional handler on a full-time basis or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.

PARADE OF RESCUES

This event is open to all rescued Gordon Setters placed through the GSCA Rescue Program.

There is no entry fee and no pre-registration is neccessary.

Each Exhibit in the Parade of Rescues will receive a commemorative rosette.

- 2. The person handling the dog must be both a breeder of record and an owner of record of the dog.
- 3. To exhibit in this class, family members must be a registered breeder and owner of record.

NOTE: AKC Rules Applying to Dog Shows. Chapter 11. Sect. 8. Neutered dogs and spaved bitches are allowed to compete in Veterans Classes only at independent specialties and/or those all-breed shows which do not offer any competitive classes beyond Best of Breed. This is an independent specialty.

Hunting Classes -- For dogs and bitches who have achieved the GSCA WD/WDR title or the AKC Junior Hunter, Senior Hunter, Master Hunter, or Master Excellent titles.

Field Trial Classes -- This is a class for dogs and bitches that have a placement in the Senior Stakes (e.g., Gun Dog or All Age) or a first in Derby Stakes at an AKC licensed FieldTrial.

NON-REGULAR CLASSES - MULTIPLE DOG ENTRIES

Stud Dog Class - For Stud Dogs and at least two (2) of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog must be entered in the Stud Dog class and shown in the ring with his Get. The Stud Dog may be entered separately in one of the Regular or Non-Regular classes at the regular entry fee of \$35, with 'Stud Dog' class indicated on the entry form in the space for additional classes at an additional \$30. Or, the Stud Dog may be entered in Stud Dog class ONLY for a \$35 entry fee.

All Get MUST be entered in one of the Regular Classes, but there is no additional entry fee for them as participants with their sire in this non-regular class. The Get only will be judged, on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disgualification or being excused under the Dog Show Rules, AKC policy or the standard for the Breed. NOTE: AKC Rules Applying to Dog Shows. Chapter 11. Sect. 8. A castrated male may be entered as Stud Dog in the Stud Dog Class and a spayed bitch may be entered as Brood Bitch in the Brood Bitch Class.

Brood Bitch Class - Same as Stud Dog Class except substitute Brood Bitch for Stud Dog, Produce for Get.

Brace Class - NOTE: Effective January 1, 2005, a Brace is defined by AKC as two (2) dogs of the same recognized breed or variety that are similar in appearance, performing in unison, and presented by a maximum of two handlers.

Both dogs competing in Brace competition must have at least one common owner. If each dog comprising the Brace is entered in an additional class, Brace entry fee is \$30. per unit. If each is not additionally entered, the unit entry fee is \$35.

PLEASE IDENTIFY ON THE ENTRY FORM, A BRACE DOG'S PARTNER IN THE BRACE.

If a dog is entered in more than one class in the show, fees are to be collected on each entry except sweepstakes, junior showmanship and multiple dog non-regular classes (American Kennel Club rule, Chapter 11, Section 2.)
- No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.
- Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the event's Show Committee. If because of riots, wars, strikes, civil disturbances, national emergencies, health emergencies, and the dictates of law enforcement or of the owner(s) of the grounds and/or facilities or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, extreme heat, heavy rains, or other circumstances including but not limited to, the condition of the facilities or grounds and/or the ingress and egress from the grounds, must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry will be made.
- Post-dated Checks and Returned Checks do not constitute a valid entry fee. The Show Secretary will add a collection fee to the amount of each returned check.
