

**Camping:**

Overnight camping is permitted on Headquarter grounds beginning Sunday evening. Only campers desiring electricity should park in the area with electrical outlets. **Michigan Recreation Passport:**

All vehicles are required to have a Michigan Recreation Passport which must be purchased upon arrival. This is **IN ADDITION** to the camping fee if you are camping.
